

Registrations are open for admission to the Municipal Kindergarten for educational year 2023/2024. Applications only online by 8 June 2023 at 2:00 p.m.

From today May 24th from 2:00 p.m., until 8 June 2023 at 2:00 p.m., the registrations are open for admission to the kindergarten of the Municipality of Cisterna di Latina for the educational year 2023/2024. Only parents of children who by September 1st 2023 have completed three months and who by December 31st 2023 have not completed three years of age can apply and are residents in the municipality of Cisterna di Latina.

For children with a severe disability, maximum n. 2 places are reserved, certified in accordance with Article 3 paragraph 3 of Law No. 104/1992.

The families of children who attended the kindergarten in the previous educational years, if they intend to confirm the frequency, notwithstanding the fulfillment of the requirements for access to the kindergarten, must submit a new application.

If you complete all the admission procedures there is availability of places, you shall proceed with the admission of children not residents in the Municipality of Cisterna di Latina who have at least one of the parents working there and subsequently the other applicants.

Children must be in compliance with the mandatory vaccinations provided for by the current legislation in force. The kindergarten is open from Monday to Friday for 42 weeks a year, with suspension of the activity during Christmas, Easter and summertime.

The family can request upon registration the timeslot 7.40 a.m. – 02:00 p.m. or 7.40 a.m. -5.20 p.m.

The parent or the person exercising parental responsibility may apply by filling in the form online conveniently from your device (computer, smartphone, tablet,...) accessing the dedicated platform, reachable from the institutional website of the Municipality of Cisterna www.comune.cisterna.latina.it through the banner.

No other forms of application shall be accepted.

The application shall state the personal data, the residence, the timeslot chosen, the family situation, and to have fulfilled the obligations of vaccination provided for by the current legislation in force.

The Indicator of the Equivalent Economic Situation (ISEE) must also be declared in the application for “benefits for minors or families with minors”, pursuant to the Decree of the President of the Council of Ministers of 5 December 2013, n.159 and subsequent amendments and additions.

In case of special educational needs, must be attached to the application suitable certification issued by competent Public Structure.

A special commission will form the rankings. The available places are n. 32, of which maximum n. 7 for the little children (3 - 12 months).

If the number of people admitted exceeds the number of places available the excess in number will be placed on the waiting list in order of ranking, and readmitted in the event of any dismissal due to waivers or forfeitures.

Provisional rankings will be published by July 7th 2023, while those final within July 28th 2023, both on the institutional website of the Municipality and at the Municipal kindergarten.

By the mandatory deadline of 4 September 2023, the families of children that are result admitted must formally confirm the registration at the kindergarten, otherwise will be considered as a waiver.
